The Midtown Neighborhood Association seeks to ensure that our business is conducted in a respectful and courteous manner and in a way that generates respect and credibility for our association. Freedom of expression about public matters is a cornerstone of the democratic process. MNA welcomes diverse views and opinions as they relate to the issues before us. For these discussions to be meaningful and effective, we must treat others with respect and dignity. By participating in this meeting, attendees agree to:

- 1. Conduct themselves in a professional and civil manner at all times by always treating all people present with respect—even during differences of opinion.
- 2. Show courtesy to others by always turning phones off or to vibrate and not engaging in texting unless directly relevant to the meeting.
- 3. Not engage in private conversations or talk while another speaker has the floor until recognized by the meeting facilitator to speak.
- 4. Under no circumstances engage in or threaten to engage in any verbal or physical attack on any other individual.

DISCUSSION & INFORMATIONAL ITEMS:

❖ National Night Out (NNO) Update:

Congratulations to Jessica Sorensen for a well-organized and very successful Midtown National Night Out, held August 2, on 22nd St. between Capitol Ave. and Matsui Alley. Additional kudos to Ed Donaghy and Meeta Lele for the help they provided as well as all members who rolled up their sleeves for a good cause. The waterslide was a big hit especially as the mercury soared. Neighborhood children enjoyed the wet and wild ride.

As a result of NNO our neighborhood association gathered 23 new memberships. Thank you, Danny, Louis and Betsy for your sales efforts.

ACTION ITEMS:

- * Board Member Vacancy On Friday, August 5, 2016, Nancy Finch sent a resignation email to Angela affective immediate. The board determined that nominations for the open seat be submitted by September 1, 2016.
- 2218 Capitol Avenue: Mike Klein requested a letter of support from MNA for this project. The board discussed MNA's level of involvement and whether writing a 'no position' letter was in fact a statement in itself. The project will go to the Zoning and Preservation Director's meeting on August 18. Tim motioned to table the discussion. Motion approved by unanimous voice vote.
- * Transportation Committee: Louis reported that the City presented the Bicycle Master Plan this week and it is 60 pages in length and includes long-term goals. The committee will analyze the document and report back to the board.
- Social Media Policy: Due a recent incident written on MNA's Facebook page the board discussed adopting a social media policy. Danny so moved, to adopt a social media policy regarding any comments posted on any of MNA's social media sites that contain profanity, attacks, or inappropriate content will be removed. Motion approved by unanimous voice vote.
- * Housing Affordability Committee: The board discussed affordable housing and rents in Midtown and the need for MNA to be a proactive partner in this discussion. - Lower American River Conservancy: The board discussed AB 1716 which creates a state conservancy program for the Lower American River. Caity so moved that MNA support AB1716. Motion approved by unanimous voice vote.
- Meeting Length: The board discussed lengthening the meeting times. The majority of members agreed to keep the meetings at two hours and consider lengthening meetings only on an as-needed basis.
