- **Consent Calendar:**

 - Danny Yost (Vice Chair) moved to approve this month's consent calendar. Motion approved by unanimous voice vote.
- **Vote for replacement board member:**
 - Alicia Doktor resigned from the board. Two members, Bill Burg and Louis Mirante, were nominated to replace her.
 - Each nominee gave a brief presentation.
 - Caity Maple moved to approve a voting process using secret ballots. The motion was approved by unanimous voice vote.

LOWER AMERICAN RIVER CONSERVANCY ACT

Assemblymembers Kevin McCarty and Ken Cooley

PROPOSAL:

Create a new state conservancy to benefit the Lower American River. This new conservancy would have the dual goals of environmental protection and increasing public enjoyment of the American River.

THE RIVER:

The American River is vitally important to the people, economy and culture of Sacramento. Since the founding of Sacramento in 1848, the American River has been a defining element of our region.

The American River Parkway is a shining example of how an urban river can be utilized as a public good, while still maintaining its environmental integrity. The Parkway encompasses 5,000 acres of riverfront accessible only by bike, foot, and horseback. Approximately 8 million people visit the American River Parkway each year, and it generates an estimated \$364 million annually for the local economy. In a poll conducted in 2006, 80% of respondents listed the development of large habitats for walking, hiking, and cycling as their top priority for how public dollars are spent.

Urban rivers are essential tools to promote the health and welfare of a modern city. This includes the benefits of physical exercise such as running, walking, hiking, swimming, and cycling along the river. It also has been shown that spending time in nature is highly beneficial to mental health by reducing stress and promoting well-being. In addition to bike and pedestrian use, the parkway provides an opportunity for citizens to appreciate the beauty of the natural habitat of the River.

WHAT A CONSERVANCY OFFERS:

State conservancies provide a framework for allocating state funds for enhancing and protecting natural lands and waterways. Since 1996, of the \$740 million of state bond and general funds allocated to rivers, \$660 million has gone to rivers with state conservancies.

Examples of possible conservancy projects include:

- *Water quality improvements*
- *Wildlife habitat restoration*
- *Cap & Trade funds for pedestrian & bike access*
- *Land acquisition, conservation*
- *Riparian restoration*
- *Educational & interpretative signage*

AB 1716 (McCarty & Cooley): Lower American River Conservancy Program

SUMMARY:

This bill would create a new state program for the Lower American River.

BACKGROUND:

The American River is vitally important to the people, economy and culture of Sacramento and West Sacramento. Since its founding in 1848, the American River has been a defining element of the Sacramento region.

The American River Parkway is a shining example of how an urban river can be utilized for public good, while still maintaining its environmental integrity. The Parkway encompasses 5,000 acres of riverfront accessible only by cyclists and pedestrians. Approximately 8 million people visit the American River Parkway each year and it generates an estimated \$364 million annually for the local economy. In a poll conducted in 2006, 80% of respondents listed the development of large habitats for walking, hiking and cycling as their top priority for how public dollars are spent.

Urban rivers are essential tools to promote the health and welfare of a modern city. This includes the benefits of physical exercise such as running, walking, hiking, swimming and cycling along the river. It also has been shown that spending time in nature is highly beneficial to mental health by reducing stress and promoting well-being.

In addition to bike and pedestrian use, the parkway provides an opportunity for citizens to appreciate the beauty of the natural habitat of the Rivers and the need to invest restoration for riparian and floodplain habitat. Investments in riparian and floodplain habitats have the added benefit of protecting surrounding areas against flood and improve water quality for downstream users.

State programs provide a framework for enhancing and protecting natural lands and waterways, in a way that provides a benefit to all Californians.

SOLUTION:

This bill would create a new program within the Wildlife Conservation Board, with the goal of enhancing and protecting the natural habitat and water conveyance of the American river.

Examples of potential projects:

- Water quality improvements
- Habitat restoration
- Improving Access
- Educational Installations
- Storm water capture
- Riparian restoration

SABA is the only regionwide organization advocating for the benefits of bicycling for recreation and utility. The Lower American River Parkway is of special interest to SABA, as the Jedediah Smith Memorial Trail through the parkway is both a very popular route for recreational bicycling and the safest and most direct route for commute trips by bike between downtown Sacramento and outlying neighborhoods along the American River.

Creation of the Lower American River Parkway Conservancy would help ensure that Sacramento County has adequate funding for trail maintenance, directional signage, lighting, trash collection and law enforcement, as well as the resources for planning and building improvements for recreational and transportation uses. 

We appreciate your leadership in bringing this bill forward to support the American River Parkway. As you are aware the American River Parkway Foundation is a non-profit organization that was established in 1983 and has the following Mission: *To support the preservation and enjoyment of the American River Parkway by fostering environmental education, stewardship and volunteer opportunities.*

Last year, the American River Parkway Foundation enlisted the assistance of 5,944 volunteers who put in 20,107 hours. On behalf of the Sacramento Environmental Commission (SEC), I write in support of AB 1716 as proposed to be amended, as it creates a new state conservancy for the purpose of preserving, protecting, and improving the American River Parkway. The SEC is a joint County/City appointed commission chartered to advise the Sacramento County Board of Supervisors and the City Councils of Folsom, Galt, Isleton, Elk Grove and Sacramento on environmental issues facing our communities. Three of these jurisdictions include lands located in the American River Parkway and are subject to AB 1716.

The SEC has discussed the provisions of AB 1716 during several meetings and received information from the Sacramento County Department of Regional Parks regarding the establishment of the conservancy on the lower American River Parkway. The SEC agrees that establishing the conservancy would benefit the environmental resources and enhance the recreational opportunities found along the Parkway by making additional funding available to support fish and wildlife habitat enhancements, contribute to stormwater management and water quality improvements, and increase the recreational value of the Parkway to residents and other users of this resource.

The SEC supports your efforts to create the conservancy in a manner that addresses Sacramento County and other local priorities regarding governance and organization. We understand that

Sacramento County has provided the author amendments to further these objectives in your bill. Again, the SEC appreciates your leadership on this important issue to create the American River Parkway Conservancy.

Dear Mr. Harris and Mr. Barron:

The Midtown Neighborhood Association's board of directors thanks the city for its effort to address safety for all travelers, including pedestrians, and we appreciate staff's work to prepare the proposed ordinance relating to bicycles on sidewalks. Our board supports the general goal of the ordinance, however, we have concerns with two elements.

First, the ordinance takes a pretty hard line against children using the sidewalk for bicycle riding. Under the proposed ordinance, anybody who allows a child to violate provisions of the ordinance would be subject to fines. We believe younger children should be able to ride on the sidewalks as they are both unsteady riders and much less visible, which puts them in considerable risk were they to ride in the street. Because of this risk, we request that the City exempt children 13 years old and under who are riding by themselves or with caregivers.

Second, the ordinance fails to give any guidance to the city manager to complete the duty that we see as the heart and soul of the ordinance: "The city manager shall establish a process for designating sidewalks where such signs are posted." We believe the ordinance should offer principals with which the city manager be guided by. We request that the city manager's designations be guided by the City's bicycle master plan: <https://www.cityofsacramento.org/Public-Works/Transportation/Programs-and-Services/Bikeway-Program>.
